ACKNOWLEDGEMENT OF RISKS AND RELEASE OF CLAIMS

Interpretation : "Himalayan Eco-Services and Products" firm, the "GHNP Community-Based Ecotourism Cooperative Society", their proprietors, members, employees, agents, associates, representatives and support personnel, shall hereafter be referred to as "Himalayan Ecotourism".

I, the undersigned, desire to participate in a trip organized by Himalayan Ecotourism.

Acknowledgement of Risks: We understand the trip will take place in the wilderness and that there are inherent dangers associated with this type of activity. The trip may include but is not limited to the following potentially hazardous activities: trekking, camping, and local ground transportation. These potentially hazardous activities can cause personal injury, property damage, death or illness.

I am also aware that medical services and facilities may not be readily available and accessible during some or all the time in which I am participating in the trip.

In recognition of the potentially hazardous nature of the elective trip, I, and my heirs, have and do hereby fully assume all risk of illness, injury, death and hereby release and discharge Himalayan Ecotourism from all actions, claims or demands for damages resulting from my participation in their trip

hereby release Himalayan Ecotourism, from all claims of negligence arising from my participation in the activity, except for the willful misconduct of Himalayan Ecotourism.

I further agree to hold harmless and indemnify the Himalayan Ecotourism for all defence costs, including attorney's fees, and any other costs resulting in connection with my participation in this activity.

Express Assumption of Risks and Responsibility: In recognition of the inherent risks of the activity in which I will engage, I confirm that I am physically and mentally capable of participating in the activity. My participation is voluntary and I will assume financial responsibility for personal injury, accidents, illness and damage to or loss of personal property as the result of any incident or accident that may occur.

I realize that Himalayan Ecotourism may find it necessary to terminate an activity due to forces of nature, medical necessities or problems in the group and/or refuse or terminate the participation of any person Himalayan Ecotourism judges to be incapable of meeting the rigors or requirements of participating in the activity. I also understand that this release relates to all claims and liability resulting from intemperate weather.
